



Vengalicat Waitlist Agreement

This Waitlist Agreement (the "Agreement") outlines the terms and conditions under which you, the Buyer, place a non-refundable deposit to secure a position on the Vengalicat Bengals waitlist for a pet-quality Bengal kitten. Please read this Agreement thoroughly. By submitting the deposit and signing below, you agree to the following terms and conditions.

Terms and Conditions

1. Deposit and Waitlist Placement

- A non-refundable deposit of **\$500** is required to be placed on the waitlist for a pet-quality kitten. This deposit will be applied toward the total cost of the kitten. The deposit ensures priority selection based on the order in which deposits are received.
- The deposit remains valid as long as Vengalicat Bengals continue breeding Bengals.

2. Commitment to Purchase

- By submitting the deposit, you are committing to purchasing a kitten from Vengalicat Bengals. This deposit is non-refundable, except under the circumstances described below.

3. Waitlist Selection and Timing

- Kittens are offered to buyers on the waitlist in the order deposits are received. Buyers are not obligated to select a kitten from the next available litter and may choose to wait for a kitten that better suits their preferences.
- The buyer must select a kitten within **one year** of being added to the waitlist. If no selection is made within that period, or if the buyer declines offered kittens, the breeder may remove the buyer from the waitlist. No refunds will be issued in this case.

4. Deposit Refunds

- If no kitten is offered within **one year** from the deposit date, a refund may be issued only if the buyer has not declined offered kittens during that time. A "refusal" includes failing to respond to communications or ignoring kitten availability posts on social media or the website.
- If the buyer has refused kittens, the breeder may either forfeit the deposit and remove the buyer from the waitlist, or allow the buyer to remain on the waitlist, maintaining their original place.

5. Communication Responsibility

- While Vengalicat Bengals will make efforts to contact the buyer about available kittens, it is also the buyer's responsibility to monitor the Vengalicat website, Instagram, and Facebook pages for updates.

6. **Kitten Availability**

- When a kitten is marked as "Available to the Waitlist" or "On Hold for the Waitlist" in communications or on social media, this indicates that the kitten is being offered to the buyer. The buyer must reach out to inquire about any kitten listed in this manner, if they have not already been personally contacted.

7. **Pricing**

- The price of kittens varies depending on factors such as color, pattern, and quality. The final price will be determined by the time the kitten reaches **6-8 weeks** of age. A Purchase Agreement outlining the final price will be provided to the buyer for review and signature.

8. **Second Non-Refundable Installment**

- A second non-refundable payment of **\$1,000** is due when the buyer selects and commits to a kitten at 6-8 weeks of age. If the second payment and signed contract are not submitted within **48 hours**, the kitten may be offered to another buyer.

9. **Failure to Make Payment**

- If the second installment is not provided or if the buyer does not sign the Purchase Agreement, the initial **\$500 deposit** will be forfeited unless prior written arrangements have been made to continue waiting for another kitten.

10. **Sale as Pet-Only**

- The kitten will be sold as a pet only and will not have breeding or show rights. The buyer agrees to have the kitten spayed or neutered by the time it reaches **6 months** of age if this has not already been done by Vengalicat Bengals.

11. **Final Payment**

- The final balance, including any applicable shipping fees, health certificates, veterinary exams, rabies vaccination, and any other fees, is due by the time the kitten reaches **10 weeks** of age.

12. **Adherence to Final Payment Deadline**

- Failure to submit the final payment by the specified deadline will result in the forfeiture of the **\$1,000 second installment** unless prior written arrangements have been made with Vengalicat Bengals.

13. Kitten Availability and Breeding Program

- Kittens available to the pet waitlist are at the sole discretion of Vengalicat Bengals. Some kittens may be held back for breeding purposes or kept within the cattery. Vengalicat reserves the right to determine which kittens will be offered for sale and which will be retained for breeding.

14. Kitten Release Requirements

- The kitten will remain with the breeder until it is at least **12 weeks** old and will receive at least two vaccinations before leaving the cattery.

15. Spaying/Neutering and Registration

- Vengalicat Bengals will ensure that all kittens are spayed or neutered by 12 weeks of age or prior to their release to their new home. In the event that this is not possible, the buyer agrees to have the kitten spayed or neutered by no later than 6 months of age. The TICA registration certificate and/or pedigree will be provided once the kitten has been altered.

16. Buyer's Responsibility

- The buyer confirms that they have obtained approval from all relevant parties (e.g., landlord, roommates, spouse) to have a Bengal kitten in their home.
- The buyer is responsible for ensuring that owning a Bengal cat complies with local laws and regulations.

17. Business Termination

- In the event that Vengalicat Bengals ceases to operate or stops breeding Bengals, all guarantees in this Agreement will be void, though the remainder of the contract will remain enforceable.

Public Dispute Clause:

The buyer agrees not to post or publish any negative information about Vengalicat Bengals, including health issues, disputes, or any other negative comments, on public forums or social media.

Final Agreement:

This document represents the full and complete agreement between the buyer and Vengalicat Bengals regarding the waitlist deposit. No other agreements, whether verbal or implied, are considered valid unless confirmed in writing and signed by both parties.
